**Board Composition**

- **Board is comprised of a minimum of 12, maximum of 20 Directors**
- **Executive Committee: up to 6 officers sit on the Executive (as well as the Executive Director)  
May include up to 2 Associate members (but cannot serve as President or Past President)**
- **Directors: 14 Exposition member Directors (minimum of 6, maximum of 14)  
6 Associate member Directors: Minimum of 1 must be a Facility Rep (no minimum, maximum of 6)**
- **All positions need not be filled, but Board must be a minimum of 12 Directors ( 6 Expo, 6 Associate)**
- **Length of Terms should be assigned so that approximately half of the Directors terms expire in one year**
- **\*\*Executive Committee term is two years, renewable once for the same office**
