

MINUTES

Annual General Meeting The Westin Calgary, Calgary, Alberta Monday, June 24, 2019 9:00AM MT

1. <u>CALL TO ORDER</u>

President Catherine MacNutt from Master Promotions Ltd. called the meeting to order at 9:00 am. She thanked Informa for sponsoring the Annual General Meeting.

2. ESTABLISHMENT OF QUORUM

Secretary Dion Burt confirmed that a quorum of voting members was present. At the close of business Friday, June 21, 116 voting exposition members and 68 associate member companies had paid their 2019 membership fees, and are therefore eligible to vote. Dion Burt noted that the quorum requirement was 37 voting members present or by proxy.

Dion Burt stated that he had been advised by staff that a total of 65 voting delegates were present at this meeting and a total of 7 voting members had provided proxies, so we do have quorum, and business can proceed.

The voting scrutineers for this meeting were Nicole Jeffrey, Michael Dargavel, and Bev Hill. All votes on motions were counted and filed with the Executive Director.

The Secretary noted that, as per the CAEM bylaws, the meeting was governed by Robert's Rules of Order in the transaction of business. Dion Burt provided an overview of how the voting cards are used during the meeting.

3. MINUTES OF THE LAST GENERAL MEETING

On a motion being made by Pat D'Alessandro, seconded by Mark Romanowicz, with the following friendly amendment by Michael Dargavel to item 2. Establishment of Quorum,

— Secretary Dion Burt confirmed that a quorum of voting members was present. At the close of business yesterday, 127 voting exposition members and 80 associate member companies had paid their **2018** membership fees, and are therefore eligible to vote. Dion Burt noted that the quorum requirement was 40 voting members present or by proxy.as circulated.

the minutes of the previous meeting held on June 25, 2018 were approved as amended.

4. FINANCIAL REPORT

Treasurer Laura Purdy, CEM presented the audited financial statements for the year ending December 31, 2018. She noted that the financial statements follow a thorough audit process conducted by the accounting firm appointed by the membership, Palmer Reed.

For the second year in a row, through the joint efforts of the Board of Directors, the Finance Committee and the ongoing financial diligence of the sub-committees, the Association has realized a surplus in the amount of \$77,476. While positive, the Finance Committee continues to operate within defined cost containment strategies, and quarterly budget reforecasting to ensure the ongoing financial sustainability of CAEM can be maintained.

It was moved by Laura Purdy, seconded by Mark Romanowicz, and carried, that the financial statements for the year ending December 31, 2018 be adopted as presented.

It was moved by Laura Purdy, seconded by Marcela Marijosius, and carried, that Palmer Reed be appointed as the auditor for the Association for 2019.
